

## **Editors' Notes**

We are continuing to put what I call the "Covid-19 Disclaimer" at the beginning of each district to help all subscribers know where to go to check on dances being held.



As said before, "Once printed, the

paper version of the Doin's can't be changed. Updating and resending the electronic version every time a dance is cancelled is simply not possible. Our recommendation for dancers is that if you are thinking about going to a dance, make a call to the club contact in the directory or check the Missouri website."

We have made a decision to postpone the Location Pull-out Section until either March/April of May/June. With most locations shut down, and some clubs having to decide to move or wait until their location opens back up, we felt this was an appropriated decision so that the pull-out section can hopefully be correct and accurate. Watch for it in a future issue.

Many clubs have not sent me a full year 2021 dance date listing. At this point, I honestly do not care if it is complete or not. Even if you have TBA's for callers, I really would appreciate your dance dates. If you know positively that dates are cancelled, please just put that in with the date. We have to fill up space in the magazine. I know how you feel, frustration is everywhere. I made 13 phone calls to find out if clubs were or were not dancing in January or February. It is hard. I do understand.

Remember – Dan is a master at inserting the word "cancelled" by your club dance date for the website. If you have a dance that is cancelled, contact Dan Wheeler, and he will take care of that for you. Fortunately, the website is going to be the most updated version for our dances, and we need your help keeping

our dancers informed during the

next months.

#### **INSURANCE NOTES**

December 7, 2020

RE: USDA Insurance Portal

The 2021 insurance portal is now available. It appears that all the glitches have been corrected.

The rate for 2021 is \$4.85 per dancer. Markel/Bollinger did raise the rate for USDA, however USDA is NOT passing that increase on to its members. Here is the link to the 2021 USDA Insurance enrollment system. http://usda.rpsbollinger.com/

This year you will continue to use the insurance portal for enrolling your clubs for 2021. After you complete the forms in the portal the system will generate them and send a copy to whoever has entered all the information and to the USDA insurance coordinator, Elizabeth Sanders. It does NOT send a copy to me.

PLEASE PRINT A COPY OF THE ROSTER and send, along with your check for \$4.85 per dancer to me. Remember: DO NOT PAY for those members who are insured through another club. ONLY pay for those members insuring through YOUR club. I will send payment to USDA. At that point, Elizabeth will send me your Certificates of Insurance for your dance locations. No certificates will be released until Elizabeth has our payment.

I completely understand the situation with some clubs not knowing if they will be dancing at the same location(s) as in 2019 or 2020. However, "pretend" and list your previous location(s). If you need to add or change locations at a later date in 2021, that is not a problem.

The 2020 portal will remain on the same page so that you can continue to add members for 2020 or request certificates for 2020. <u>It is important that no 2021 information be entered into the 2020 portal or that no 2020 information be entered into the 2021 portal.</u> Both are very well marked.

We have extended the insurance enrollment deadline to <u>January 15, 2021.</u> However, the sooner you get it done, the sooner the \$50 per club rebate check will be sent to the District for distribution to clubs.

If you have questions, please let me know. Please have patience with me, as I am learning this job, too. If I do not know the answer to your question, I will go to Elizabeth for help.

attendant air and room.

- 3. Raise joined hands as high as possible in the form of an arch.
- On seeing this signal, the caller or hall monitor will immediately place an emergency call for aid.







Hammontree of the Philippines also survives (but not yet confirmed at the time of printing) other relatives and friends.


She was preceded in death by her parents and two brothers, John Richard Hammontree and an infant Raymond Hammontree.



## 2020 Caller / Cuer Hall of Fame Chris Wildhagen

Like many other I began calling accidently. I blame my brother for this mishap. Noel (my brother) called one day, "You all need to go to square dance lesson with us Tuesday night." Of course, I had my doubts. Noel, Linda and I danced with a kids club from the mid-50's through the mid-60's. Fourteen years later I felt a little rusty. "Aw, come on, you'll have fun," he said. So we went, and dang it was fun!



The caller teacher was a high school pal of Noel's. And as a friend loaned Noel two 45rpm square dance records to learn. One accident led to another when Noel brought the records to my house and asked me to return them to the caller on Tuesday night because he had to skip class that week. Curiosity is dangerous. I decided to try (just for fun) to learn to call those songs. I learned them in about two days and returned them on Tuesday. The caller asked if Noel had learned them. I said "No, but I did." As a result, I called both songs that night without a cue sheet. The caller didn't say much, but handed me two more records to learn. Soon I was asked to call a tip at an area dance. Area callers were happy to give a newbie a chance to call a tip. If you did okay, you would be asked to do another one at the next dance.

After teaching two mainstream and one plus class start to finish, I started a club in 1984 called the Crocodile Rockers (a plus club). The Croc's evolved into the St. Joe Squares and is still going today. Soon afterward, I was hired as the club caller for the River Bend Promenaders of Atchison, Kansas.

Currently I am the club caller for St. Joe Squares, the Maysville Wranglers, and the Happy Times Squares of Lawrence, Kansas. I also call regularly for clubs in Iowa, Nebraska, Kansas as well as Missouri.

After 40 years of calling, teaching, dancing and travelling, dang it is still fun! My goal is always to share that fun with the dancers.

#### Call Ahead FIRST Before Traveling to a Dance.

Severe weather, e.g. snow, icy roads, and other winter weather events such as Flooding, Thunder Storms, Tornados or other concerns and issues may cause the club you plan to visit to cancel their dance at the last minute.

During these weather events, or if a weather event is forecast, call the club contact ahead of time to ensure that the dance you are planning to attend is either going to happen as scheduled, or has been cancelled. You can find a list of club contacts at the back of the Show-Me Doin's.

You can also tune in to your local weather forecasts on your radio, television, computer and smart phone apps before traveling, regardless of the reason of travel.

A very good investment is a NOAA Weather Radio. These can be purchased at almost any electronics store or department store. Be sure to buy one with the SAME Warning Alarm Capability and a battery backup. The voice of the National Weather Service provides alerts concerning severe weather 24 hours a day.

You can also go to weather.gov on the internet and click on whichever state you are in for the latest watches, warnings, advisories and forecasts.

If you know that road closures may be a problem due to winter conditions or flooding, tornados, severe wind conditions, or road construction, go to the State Traffic and Road Closures on the internet to find out the condition of your planned route to a dance or other event.

REMEMBER: Never attempt to drive through flooded low water crossings or other waters on the roadways.

We want to see you across a square. So, travel safely and sanely.

Roll Call: : Liz Rooks. Full Quorum achieved. (7 Exec. Brd / 16 Dist Dir / 10 Staff/PP). Introduction of guests: Pat Auriene introduced Charles and Linda Lile, Richard & Trudy Clawson, from Tanglefoot Squares and Debbie Moffitt of the Beaux and Belles introduced Chris Shoemaker. These visitors were from the Northeast District.

**Approval of April 19 Minutes:** President Goucher asked for corrections or additions to the August 16, 2020 minutes.

Edythe Weber moved to accept the minutes as presented. Motion was seconded and carried.

**Treasurer's Report:** Rosa Davis reported a beginning checking balance as of July 31, 2020 \$5,892.58, Revenue of \$475.49 and Expenses of \$2,639.43. CD redemption \$10,543.23. The ending checking account balance as of September 30, 2020 was \$14,271.87. Total CDs and interest amounted to \$30,528.01 for Total Funds on hand of \$44,799.88. The Treasurer's report will be submitted for audit.

Memorial gifts of \$25.00 each were sent to the USDA Scholarship Fund, VFW Post 4043, and Honor Flight KC in honor of Jim Weber. This distribution was approved by consensus of the Executive Committee via email.

**Membership and Club Longevity:** Rosa Davis reported we have 46 clubs this year. Longevity award was awarded and presented to Tanglefooters, Southwest District, for 45 years.

Fred also presented the Longevity awards to the other clubs who had been recognized at our previous online meetings: Little Dixie Squares and Tanglefoot Squares (NE) River City Squares (West Central), Dandy Dancers (St. Louis), Cross Trailers (NW), and Twirl-A-Rounds (SW)

**Correspondence:** Liz Rooks reporting. No correspondence received. The following cards have been or will be sent: Sympathy cards to Edythe Weber and Kenny Zeller's Family, and a Thinking of You card to John & Bev Stuart.

**Caller-Cuer Recognition:** Bev Stuart announced Chris Wildhagen as the Caller of the year for 2020.

**Square Dancers of the Year:** Liz Rooks introduced the 2020 Square Dancers of the Year, Richard & Trudy Lawson and presented their plaque and badges.

**Boundaries and Relations:** Dave Byers. Peppy Promenaders submitted appropriate paperwork requesting to move from the West Central District to the Northeast District.

Redistricting: The majority of the committee talked about 5 districts. However, I feel personally it needs to be 4 districts, because almost immediately we would have one district in the same condition as a few are now.

I am ready to open this up for discussion to see what the majority of the Board wants to do. However, I think we should wait until after the first of the year, or whenever most clubs are dancing again, to see how many clubs/dancers we will actually have when the pandemic is over

**Constitution and Bylaws:** Dave Shafer. Making sure that all of the revisions have been inserted into the Constitution & Bylaws and Standing Rules so the most current versions can be posted on the Federation website.

Publications: Carol Morris. No report.

**DOIN'S Editor:** Edythe Weber reporting. We are continuing to put what I call the "Covid-19 Disclaimer" at the beginning of each district to help all subscribers know where to go to check on dances being held.

vAs said before, "Once printed, the paper version of the Doin's can't be changed. Updating and resending the electronic version every time a dance is cancelled is simply not possible. Our recommendation for dancers is that if you are thinking about going to a dance, make a call to the club contact in the directory or check the Missouri website."

The next deadline is November 25, the Wednesday BEFORE Thanksgiving, for the Jan-Feb 2020 issue. Please send articles early; it will be greatly appreciated. We all have many holiday family get-togethers over that week and weekend, so get your articles in early.

#### Important deadlines NOVEMBER 25:

1. Complete 2021 dance listings for all clubs. If you don't know what you are doing yet, just guess. I need something, even if it is TBA.

2. Make sure we have accurate and correct directions and physical address for your dance location(s). All of them, even temporary locations. This is the issue that we print the pull-out Location Listing. Also a contact phone number, cell if possible, in case somebody needs to contact you while they are on the road to your dance. Let's make it as accurate as possible.

3. Club Directory — make sure the person listed in the Doin's is an active member who will know what to tell people if they call. It helps to have a cell phone, because if you are at the dance, who's home answering your phone?

Remember – Dan is a master at inserting the word "Cancelled" by your club dance date for the website. If you have a dance that is cancelled, contact Dan Wheeler, and he will take care of that for you. Fortunately, the website is going to be the most updated version for our dances, and we need your help keeping our dancers informed during the next months.

**DOIN'S Circulation:** Ruth Ann Reynolds reporting. Subscriptions for the November/December issue of the DOIN'S are 225, 2 exchange copies and 14 for staff, historian and post office for a total mailing of 271. We had 59 electronic subscriptions, 34 renewals 3 new subscriptions and no new student copies. We will be sending out 62 postcards to subscribers whose subscriptions will expire with the November/December issue.

Financial report: The balance brought forward was \$100 with a total income of \$555.00 from subscriptions & clubs. Expenses: postage \$23.60 and Office Depot \$25.25. A check for \$506.15 given to the Federation. The ending balance is \$100.

**DOIN's Advertising:** Dave Shafer reporting. We had a balance brought forward of \$100. We took in revenue from DOIN'S ads and caller/cuer listings of \$¬934.00 and Doin's Subscription \$15.00 and Expenses totaled \$22.75. A check was mailed to the Federation for \$926.25 leaving a balance of \$100.

Promotions and Advertising: Jack & Becky Rockaway. No report.

State Festival Site Screening: Dave & Penny Byers. NE has checked out numerous

locations for the 2022 State Festival with several locations having negative responses. They discussed 3 possible locations for the 2022 State Festival (Sedalia State Fair Grounds, Cowan Center in Lebanon, and Four Seasons at Lake of Ozarks).

The NE committee voted to have the 2022 State Festival in Lebanon at the Cowan Center, October 7, 8 & 9 (the second weekend)

The State Festival Site Screening Committee recommends the approval of the NE Committee's recommendation on when and where to hold the 2022 State Festival.

**Insurance Coordinator:** Edythe Weber, Temporary Chairman, reporting. 1,100 dancers are insured through Missouri Federation and 357 dancers are insured through other federations for a total of 1,457 Missouri dancers in 46 clubs.

There has been no activity since the last report on August 10, 2020.

- If your club has a new insurance person, please let me know their contact information: Name, Address, Phone and Email. I will contact them with instructions on how to use the new enrollment portal. When you use the portal to add a dancer or a dance facility please notify me what you did via email at moinsurance@kc.rr.com. You should never delete a dancer from your roster after initial enrollment.
- The 2020 Insurance premium is \$4.85 per dancer
- Please do not do anything for 2021 insurance until you have been notified to do so. As of this writing (Oct. 12, 2020) we do not know the 2021 rate yet, and the Bollinger website has been under an upgrade for 2021 and is not ready yet.

I am going to complete this enrollment season and am looking for a replacement for Jim to begin the new year. If you know of someone who might be interested, or who you want me to talk to, please let me know.

USDA is going to work with me, and Dan Wheeler will still do upkeep on the Missouri website for forms that are still there.

• I promise we will get through this enrollment period.

**License Plate:** Catherine McLemore reporting. No report.

**USDA:** Edythe Weber reporting. As of this meeting, USDA Insurance Coordinator, Elizabeth Sanders, has not heard from the insurance company what the 2021 insurance rate for dancers will be. They are as frustrated, if not more, than we are because this effects multiple states, organizations, dancers, etc.

Please bear with us as we continue to get the information from the main company office so we can get it out to the dancer organizations.

At this time, USDA is planning on the annual meeting in Jackson, Mississippi on Wednesday, June 23, 2021.

**ARTS:** Edythe Weber reporting. Nothing additional to report at this time.

**District Presidents' Report:** Liz Rooks reporting. Six district presidents were in attendance.

The Northwest District agreed to host the first district meeting of 2021. Other hosting clubs/districts will be determined later.

Each one shared what has been happening in their district in respect to dancing. Every district has some dancing occurring whether it be in a club's regular venue or if the club has found another venue for the time being. The dancing is a combination of square and round dancing.

**Youth and Children's Dance:** Merle Hall. Received word from the 4-H groups in Kirksville, Randolph, Macon and Johnson counties that they want to start back with square dance lessons and would like us to do some demos at each region's Energizer Days. Trying to set that up ASAP. Has some students in Macon who are not a part of a 4-H Club who are interested in learning to square dance.

Nominations Committee Report: Bev Stuart shared the following slate of officers for 2021: President – Dave & Penny Byers, 1st Vice-president – Merle and Madeline Hall, 2nd Vice-president – Dave Shafer, 3rd Vice-president – Open, Secretary – Liz Rooks, and Treasurer – Rosa Davis.

Bev reported she had contacted a couple of potential candidates for the 3rd vice-president position, however, at this point, no one has accepted.

Two or three names were suggested from the floor. Cathy Hall from the St. Louis District accepted the nomination.

**Mo Fed Scholarship:** Bob & Shirley Turner. The 2020 scholarship recipient's check has been sent to her school. Bob reminded everyone of who is eligible to apply and that the information for 2021 would be available after the first of the year.

**2020 State Festival:** Liz Rooks. We are about to wind up business for the 2020 State Festival. Souvenir shirts or on sale at special prices until November 15. We want to have it all wrapped up by December 1.

Registration forms and shirt order forms were passed out to everyone present and will be sent to Dan Wheeler for posting on the website.

**2021** State Festival: Dave Shafer. The 2021 State Festival will be October 8-10, at the Cowan Civic Center in Lebanon. The theme for 2021 is "Put the Spring Back in Your Step – Dance" and the colors are the dancer's choice of autumn colors.

#### **Old Business:**

Following discussion of for district reasons and against realignment. Weber Edythe made a motion to table further discussion and action Motion was seconded and the motion carried. on this to a later date.

Merle Hall reported he is following the suggestion made last meeting to hold off on the filing of our 501(c)(3) Non-Profit application until after the first year. He will file that after the first of the year and Rosa will provide the necessary 2020 financial information.

#### **New Business:**

Edythe Weber thanked everyone for their cards, prayers, and donations made in honor of Jim.

Merle Hall made a motion the Federation purchase a year's Zoom subscription as that provides a better price. Motion seconded and carried.

He taught his first class in 1963 after borrowing money from his folks to buy a small sound system and was able to pay them back before the class was over

After receiving his doctorate in 1976, Mike joined CALLERLAB in 1977 and has been Chairman of several committees as well as an annual presenter for interest sessions and seminars at CALLERLAB conventions. Mike served on the Board of Governors from 1984 to 2003 and completed a two-year term as the CALLERLAB Chairman of the Board in 1994. He was also awarded the Milestone Award in 2001 by two of his mentors, Bob Van Antwerp and Bob Osgood. He submits monthly CALLERLAB Viewpoint articles to American Square Dance Magazine and his articles have appeared in various publications around the world.

Mike teaches, calls Basic through C-1, prompts contras, and enjoys doing dance party events when his schedule allows. He is a strong advocate for the Multi-Cycle Method of teaching new dancers and enjoyed a very successful program with the Valley Trailers Square Dance Club in Northridge. Mike currently teaches for the Buckles & Bows in Thousand Oaks, California.

Mike records for Rhythm Records, regularly does caller clinics, and helped produce an Introduction to Contra Dancing package for R & R Video, with the California Contra Caller's Association.
