SHOW-ME DOIN'S FOR ONE YEAR

*Submit the following to the State Board of the Missouri
Federation of Square and Round Dance Clubs:*

1. New caller show proof of successfully completing an acknowledged calling school within the past 12 months.
2. Be a member of an acknowledged caller association — CALLERLAB or American Callers Association.
3. Reside within a district of the Missouri Federation of Square and Round Dance Clubs and/or be affiliated with a club of the Missouri Federation.
4. Show proof of BMI/ASCAP licensing.
5. Provide business card or desired ad layout for the *Show-Me Doin's*.

Send all requested information to the President of the Missouri Federation of Square and Round Dance Clubs for presentation of request at the next available State Board meeting.

TRAVEL MISSOURI PROGRAM

TRAVEL MISSOURI is a statewide visitation program of the Missouri Federation of Square 'n Round Dance Clubs, Inc. designed to encourage dancers to visit other clubs, districts and attend the State Festival.

Participants may let people know what they have done by displaying the TRAVEL MISSOURI Bar with the District dangles identifying where they have danced. ALL SQUARE AND ROUND DANCES ARE TRAVEL MISSOURI DANCES.

Participation in TRAVEL MISSOURI cost nothing; however, the participant(s) may at their discretion obtain the Travel Missouri Bar and earn dangles from the Program Manager. To earn dangles you will need a TRAVEL MISSOURI card (which may be obtained from the Program Manager, District Presidents, or Club Presidents or by visiting www.squaredancemissouri.com). Each time a participant who has obtained the Travel Missouri Bar visits a different district, he or she may have a card signed by the host club. To receive the Dangles, send the signed card to the Program Manager and the dangles and a new card will be sent to you. One card is good per couple or individuals.

Subject: Coronavirus (COVID-19) – Updated response from the United Square Dancers of America
Date: March 20, 2021

Hello dancers and dance leaders,

We would like to begin this COVID response update by reminding our readers that the United Square Dancers of America (USDA) is an organization that is run by dancers for dancers. We are educational in nature and not a governing body. The ideas expressed in this article are suggestions presented for individual dancers and dance leaders to consider as they begin to think about resuming dancing.

We would be remiss if we didn't begin by saying that different areas of the country are in various phases of reopening due to the state and local guidelines. Anything we suggest here should be considered in light of current conditions in your geographical area. As dances begin to open up we encourage everyone to respect the right of individuals to make the decisions they are most comfortable with in regards to whether or not they are ready to return to dancing. We continue to encourage dancers and dance leaders to follow the safety guidelines outlined in the first USDA Response to COVID 19 as posted on the USDA website, usda.org in conjunction with state and local guidance.

Recently the USDA Webinar Series, “Beyond the Dance Floor”, hosted Mike Hogan as the guest presenter. Mr. Hogan has been a square dance caller for 45 years, has a 30 year career in the field of marketing, and is currently Market President for iHeart Media. He has combined his expertise in both fields to present many fresh ideas on the why and how of marketing square dancing. Mr. Hogan's hypothesis is that recruiting new square dancers has become difficult because the approach is backwards. He suggests, “People haven't associated square dancing as a product that satisfies a need or want.

The solution is to promote the product now and recruit the dancers later!” For more details please go to usda.org , from the homepage click on “webinar”, then “February 13, 2021”. All of those links will provide details of Mike Hogan's presentation including his slides and video of the webinar. We strongly encourage you to check out this free resource for new ideas.

At our January 2021 ZOOM Winter Meeting of the USDA Executive Committee, Barry Clasper was a guest speaker who presented on “Social & Sustainable Square Dancing” or commonly referred to as SSD. This program was developed within CALLERLAB with one of the principle authors being the late Jerry Story. Much more information can still be found on the web at jerrystory.com. Information can also be found on the CALLERLAB Knowledge website at <http://callerlabknowledge.org/?s=ssddoc>. Sadly the social aspect of square dancing (SD) has eroded over time. The SSD program reintroduces the social aspect back into square dancing. The goal is to create a social activity that people will want to come back and have fun at. The SSD approach is designed to be more casual rather than a continuing learning process. Following over 15 months of social isolation, the general population is ripe with the desire to get out, socialize, and do something fun together.

Now is the perfect time to get together with your club and set your plan for moving forward in the post COVID isolation era. A combination of new marketing ideas gleaned from Mike Hogan’s webinar presentation and CALLERLAB’s Social (& Sustainable) Square Dancing looks like it could be the ticket to the rebirth of the activity we love so dearly. It may look a little different, but what is the goal? Do we want square dancing to continue to die a slow and painful death or do we want to keep it alive and vibrant? Do you want more information? The USDA webinar series, “Beyond the Dance Floor” has two more sessions planned that will be extremely helpful as square dancing moves forward. Please keep in mind that all webinar sessions will be available on usda.org under the “webinar” tab on the home page.

Looking forward to dancing with you soon.

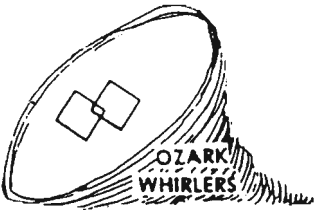

EMERGENCY CALL FOR MEDICAL AID

1. When a dancer goes down, a second dancer attends to him/her.

2. Remaining dancers join hands and take a step backward. This will allow the injured person and attendant air and room.

3. Raise joined hands as high as possible in the form of an arch.

4. On seeing this signal, the caller or hall monitor will immediately place an emergency call for aid.

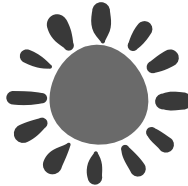

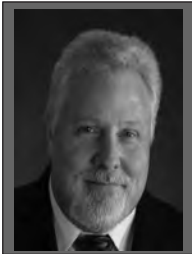

1. When a dancer goes down, a second dancer attends to him/her.
2. Remaining dancers join hands and take a step backward. This will allow the injured person and attendant air and room.
3. Raise joined hands as high as possible in the form of an arch.
4. On seeing this signal, the caller or hall monitor will immediately place an emergency call for aid.

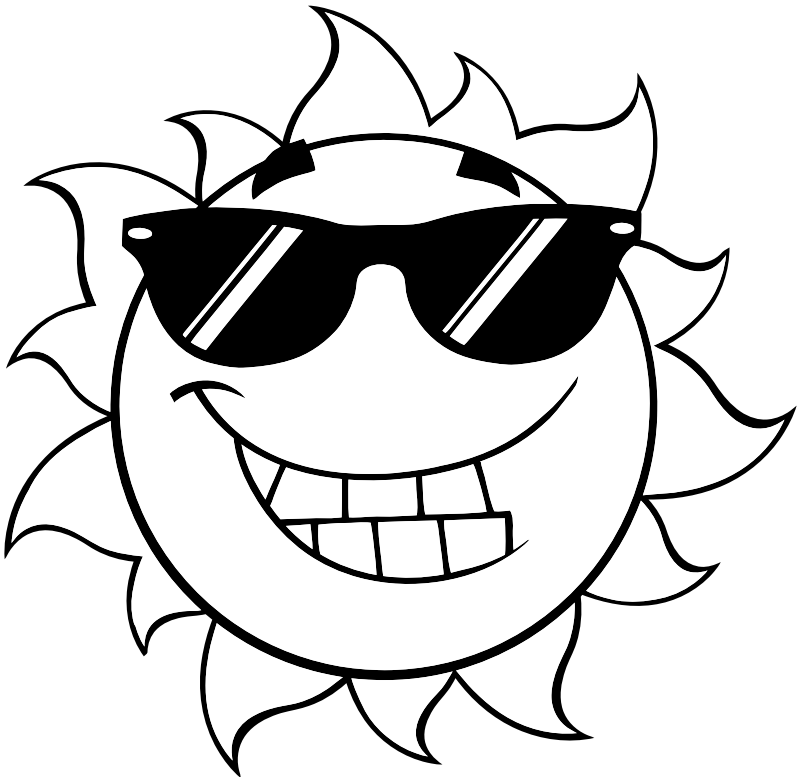

MO Fed Scholarship: Bob & Shirley Turner. Dave Byers reported for Bob that no applications were received by the deadline; however, one was received after the deadline and the applicant was aware their application was late. Bob asked that the state consider extending the deadline to June 1.

2021 State Festival: Dave Shafer. Dave gave the following report: To date 48 dancers are registered (39 paid and 11 complimentary). Projected expenses of \$7,055.00 (Cowen Center rental, Featured Caller & Cuer contract fees plus 4 nights lodging, caller/cuer recognition luncheon, and miscellaneous items).

283 paid registrations are needed to cover projected expenses and break even (this does include any income we might have from a silent auction, raffle(s), shirt sales, etc.

Some Festival packets were given out today and the others are going this week.

Need to make hotel reservations early as there is a fishing tournament also taking place that same weekend. Registration forms and shirt ordering information are also available on the Federation website.

Suggestions were offered regarding ways to support the dance or possibly scale back a bit.

Will reassess the situation at our July meeting.

Old Business:

Cathy Hall gave the second reading of the proposed changes presented at the February meeting to the Constitution and Bylaws. Vote taken and the proposed changes were accepted.

Merle Hall reported all of the necessary paperwork for the 501 (C) 3 application has been submitted; has had no response as of this date.

Dave Byers asked for discussion of ways to address the possible future budget deficit situation with suggestions offered. It was suggested to appoint a subcommittee to pursue this and report at the next meeting. The committee will be Cathy Hall, Rosa Davis, and Robert Turner with Dave and Penny Byers as ex officio members. Send any suggestions or ideas to them.

Art Kruse shared the following information regarding an opportunity to participate in a bicentennial event hosted by the State Historical Society of Missouri on Saturday, August 7th:

The Promotions Committee, chaired by Carolyn and Fred Goucher will work with Danielle Griego, State Historical Society of Missouri and get promotional material out.

New Business:

Delegates for USDA Annual meeting:

Four delegates are needed; delegates can attend in person or via Zoom. Dave Shafer, Roslie Mogerma, Ruth Ann Reynolds, and Catherine McLemore volunteered to be delegates. Dave & Roslie are planning to attend in person and Ruth Ann and Catherine via Zoom.

Proposed Standing Rule Changes:

Proposed changes to the following parts of the Standing Rules were also read: Article III, Section 1, Article IX, Sections 5 and 6; Article X, Sections 2D, 3C, 3E7; Article XI, Sections 1, 2 and 3; Article XVI, Section 2B; Article XVI, Section 2B; and Article XIX, Section 6A. (See the proposed changes at the end of the minutes.)

Vote was taken and the Standing Rules were adopted with an effective date of April 18, 2021.

Scholarship Application Deadline Extension:

Fred Goucher made a motion not to extend the scholarship application deadline; motion seconded and carried.

Carol Hershey suggested having committees review deadlines for submitting information in comparison to the new schedule of meetings.

Cathy Hall responded the work of some of the committees that was tied to a board meeting can be conducted via e-mail, conference call, Zoom, etc.; however those decisions that need to be made by the board should be looked at to see if any changes are necessary for their scope of work.

Need to decide on date and location for the July Board Meeting. The St. Louis district has usually hosted the August meeting and Cathy Hall wasn't sure if they would be able to find a place to meet.

Bev Stuart reported Jefferson County in the St. Louis District is not as restrictive and she would be glad to work on locating a place to host the meeting. July 25th was decided as the date for the meeting. Further information will be forthcoming.

Article VI, Meetings; Section 1: Regular

AS CURRENTLY READS:

Regular meetings of the board of directors shall be held six times a year, hosted by member clubs. Meetings will be held in the district in which the club is a member. A dance, the night before the meeting, shall be held if possible. Meetings shall be on the second or third Sunday of February, April and August; the meeting designated as the festival meeting shall be on the Sunday of the annual festival, and the June and December meetings shall be on the first or second Sunday. Within ten days of each state meeting, each board of director member will receive uncorrected minutes of said meeting, either by e-mail to those who have e-mail addresses, or mailed to those members who do not have e-mail addresses. Notices of upcoming meetings with a copy of the previous meeting minutes and agenda of all business known to the executive committee to be brought before the board of directors shall be either e-mailed to those with an e-mail address, or mailed to those members of the board of directors who do not have an e-mail address, postmarked at least 10 days before the meeting. The meeting dates for the coming year shall be adopted at the December meeting.

CHANGE TO READ

Regular meetings of the board of directors shall be held **four** times a year, hosted by member clubs or **via conference call**. Meetings will be held in the district in which the club is a member. A dance, the night before the meeting, shall be held if possible. Meetings shall be held on **a Sunday** in the months of January, April, July and October/November, with the meeting designated as the festival meeting held on the Sunday of the annual festival. Within ten days of each state meeting, each board of director member will receive uncorrected minutes of said meeting, either by e-mail to those who have e-mail addresses, or mailed to those members

who do not have e-mail addresses. Notices of upcoming meetings with a copy of the previous meeting minutes and agenda of all business known to the executive committee to be brought before the board of directors shall be either e-mailed to those with an e-mail address, or mailed to those members of the board of directors who do not have an e-mail address, postmarked at least 10 days before the meeting. The meeting dates for the coming year shall be adopted at the **October/November festival** meeting.

Article VI, Meetings; Section 2: Annual

AS CURRENTLY READS:

The October meeting of the board of directors shall be designated as the annual meeting, time and place to be determined by the president with approval of the executive committee.

CHANGE TO READ:

The October meeting of the board of directors shall designated as the annual meeting and **held** on the Sunday of the annual festival, if feasible.

Article V: Officers and Their Duties; Section 4: Nominations and elections

AS CURRENTLY READS:

A. A nominating committee shall present a slate of officers at the August meeting of the board of directors. Nominations for each office may also be made from the floor. Consideration should be given to nominating only one officer from a district, if possible, so that representation may be diversified. Consent of nominees must be obtained before their names are presented.

CHANGE TO READ:

A. A nominating committee shall present a slate of officers at the **July** meeting of the board of directors. Nominations for each office may also be made from the floor. Consideration should be given to nominating only one officer from a district, if possible, so that representation may be diversified. Consent of nominees must be obtained before their names are presented.

Article V: Officers and Their Duties; Section 3: Terms of office

AS CURRENTLY READS:

Officers shall serve from January 1 to December 31, with the following exception: the incoming president begins his/her term upon receipt of the gavel at the end of the December meeting

Article V: Officers and Their Duties

AS CURRENTLY READS:

- Section 3: Terms of office
- Section 4: Nominations and elections

Currently, there is no statement within the Constitution regarding the Fiscal Year of the MO Federation. A motion was made at the February 21, 2021 meeting to have it added.

CHANGE TO READ:

ADD

Section 5: Fiscal Year – The Fiscal Year of the federation shall be January 1 through December 31.

APRIL 18 - PROPOSED STANDING RULE CHANGES:

Article III: Board of Directors’ Meetings

AS CURRENTLY READS:

The festival meeting shall be on Sunday of the festival, and the June and December meetings shall be on the first or second Sunday. CHANGE TO READ:

Section 1. The meetings shall take place during the following months: January, April, July, and October. Should cancellation of a meeting be necessary, it shall be scheduled on the following Sunday at a place selected by the executive committee.

Article IX: Selection of the Caller/Cuer Hall of Fame Nominee

AS CURRENTLY READS:

Section 5.

The recipient must be nominated by the president of an affiliated district and supported by at least two presidents of affiliated clubs (or representatives to the district if the club has no president) from the nominating district. The nominations close on August 1st of that year and no nominations will be held over to the following year.

Section 6.

The selection committee chairman shall make copies of the nominations received by August 1 and mail them to the committee members for consideration. The selection will be made at the August federation meeting.

CHANGE TO READ:

Section 5.

The recipient must be nominated by the president of an affiliated district and supported by at least two presidents of affiliated clubs (or representatives to the district if the club has no president) from the nominating district. The nominations close on August 1st and must be post-marked or emailed by August 1st. No nominations will be held over to the following year.

Section 6.

The selection committee chairman shall make copies of the nominations post-marked or e-mailed by August 1 and mail or e-mail this information to the committee members for consideration. The chairman will conduct an in-person meeting, video meeting, or a telephone conference with the committee members by September 15th to select the recipient(s). The name of the recipient(s) will be kept secret until the presentation at the state festival.

Article X: Selection of Square Dancer(s) of the Year

AS CURRENTLY READS:

Section 2D. The selection committee chairman shall make copies of the nominations received by July 15 and mail them to the committee for consideration. The selection of the recipient(s) will be made at the August federation meeting.

Section 3E-7. Nomination submissions shall be for endorsement by the District of which the nominee's club is a member by July 1 and forwarded to the Square Dancer of the Year selection committee so it arrives no later than July 15th.

CHANGE TO READ:

Section 2D. The selection committee chairman shall make copies of the nominations that were post-marked or e-mailed by August 1 and mail or e-mail this information to the committee members for consideration. The chairman will conduct an in-person meeting, video meeting, or a telephone conference with the committee members by September 15th to select the recipient(s). The name of the recipient(s) will be kept secret until the presentation at the state festival.

Section 3E-7. Nomination submissions shall be signed by two supporting club presidents from the nominating district (or representatives to the district if a club has no president) and endorsed by the district president.

Article XI: Appointive Committees

AS CURRENTLY READS:

Section 1. Each year before the February meeting of the board of directors, the executive committee shall review the appointive standing committees, their purpose and the needs of the federation. Appointment of memberships to all standing and / or select committees, with the exception of those whose memberships are set out in the Constitution and Bylaws, and the audit committee, shall be made at the executive meeting prior to presenting them at the February meeting. The audit committee membership shall be appointed at the December meeting of the year for which they will be auditing.

Section 2. At the February meeting the president shall present to the board of directors any additions to or deletions from the appointive standing committees and/or any newly defined purposes of such committees.

Section 3. All appointees and committees from the current year shall be relieved of their duties at the close of the December meeting.

CHANGE TO READ:

Section 1. Each year before the January meeting of the board of directors, the executive committee shall review the appointive standing committees, their purpose and the needs of the federation. Appointment of memberships to all standing and / or select committees, with the exception of those whose memberships are set out in the Constitution and Bylaws, and the audit committee, shall be made at the executive meeting prior to presenting them at the January meeting. The audit committee membership shall be appointed at the October meeting of the year for which they will be auditing.

Section 2. At the January meeting the president shall present to the board of directors any additions to or deletions from the appointive standing committees and/or any newly defined purposes of such committees.

Section 3. All appointees and committees from the current year shall be relieved of their duties at the close of the year.

Article XVI: Club Longevity Awards (Treasurer)

AS CURRENTLY READS:

Section 2B. The Treasurer will distribute the badges to the District Presidents at State Board meetings for upcoming months as listed:

1. February meeting – March and April
2. April meeting – May and June
3. June meeting – July and August
4. August meeting – September and October
5. October meeting – November and December
