"In order to further the stated goals and objectives of the Missouri Federation of Square 'N Round Dance Clubs, Inc., there <u>may</u> be selected from the club callers or cuers of Missouri Federation clubs one person to be identified as the recipient of the "Caller / Cuer Hall of Fame" honor."

The general criteria for nomination, as set forth by the Missouri Federation Standing Rules, are highlighted here and will be verified by the nomination committee:

- 1. Calls or cues for a club that is currently a member of the Missouri Federation.
- 2. Has been an active caller or cuer for a period of no less than 20 years.
- 3. Has participated in the annual state festival at least five times out of the most recent 10 years of active calling or cueing.
- 4. Has not previously received this award.

Districts may submit more than one nomination per year. Callers or cuers who have been previously nominated, but not selected, may be nominated again.

On the reverse side is the form to use for nominating a candidate for the Caller/Cuer Hall of Fame. If needed, additional forms may be found on the website at: forms.squaredancemissouri.com. This nomination form, complete with required signatures, must accompany the nominee's resume or it will not be accepted.

The deadline for nomination submissions is July 1, 2025.
